

Student Visa Checklist

**** Applicants are requested to submit and upload ALL the documents even if it is optional choices ****

Section A: Standard Documents

- ❑ Verification of your studying course.
 - (a) **Admission Letter (Original) , Bonafide Letter (Original)**
from a recognized Indian educational institution which MUST include:
 - Applicant's full name as on passport
 - Applicant's grade / course
 - Course duration which should be stated with detailed dates
 - Issuing date which MUST be within one month of application date
 - School name/ location of school
 - School stamp seal and issuer's signature
 - (b) Bank guarantee or statement (In case of minor applicant, the parents/guardian can submit their bank statement)
-The issue date must be within 1 week at the time of submission.
 - (c) A statement of minimum cost during the academic period (including tuition, stay, and living expenses)
 - (d) Financial Guarantee letter (from your parents/guardian/yourself for supporting, date of issue)
 - (e) Certificate of Family Relationship (if your parents are your supporter)
 - (f) Certificate of affiliation of the institution from education board (college, university – UGC, AICTE / elementary, middle, high school – IB, CBSE, etc.)
* If your admission/bonafide school is not affiliated to education board directly, please attach MOU between both school/institutions.
 - (g) Certificate of registration
(This is NOT required if you apply for an university/college)
 - (h) Undertaking from their parents/guardian/yourself for supporting (Issued date, signature)
 - (i) Receipt of fee paid to the school/college
 - (j) Valid India visa (copy) - **If you have valid India visa**
- ❑ **If you have a provisional admission letter [!] Interview is required**
- ❑ In case of Participation in Exchange Program [!] **Interview is required**
 - (a) Confirmation of Exchange Program issued by Korean University
 - (b) Certificate of Enrollment
 - (c) Invitation Letter inviting the student issued by Indian University
 - (d) MOU letter- mou between the colleges has to be valid
(Bank guarantee & Undertaking are not required)

Note: Handwriting documents are not acceptable. Only acceptable for sign of the documents.

* Please Note :

- New visa regulations (since Jan 2022)
